VPK ATTENDANCE REQUIREMENTS:

The VPK Uniform Attendance policy is based on the 80/20 Formula. The 80/20 Formula states that if a child attends eighty percent (80%) of the total 300 VPK hours, (or is absent for less than 20% of the total VPK hours), the provider will receive a full reimbursement. Providers will receive monthly payments, including absences up to twenty percent (20%) per month. However, if a child is absent more than 20% in one month, the provider will not be paid for those additional days of absence for that particular month. The provider will, instead, be reimbursed for those additional days of absence at the end of the program year if the child completes 80% of the total 300 hour program. **Therefore, a child cannot miss more than 20% of 300 hours or 60, which translates to a maximum of 7 allowable absences.**

Regular attendance is REQUIRED in this program. It is important that your child attends every day in order to receive the maximum benefit of this program so that your child is prepared to succeed in Kindergarten. The Director will discuss excessive absences with the child's guardian if necessary. The Director reserves the right to ask a family to leave the program if a pattern of excessive absences is established.
